The <u>latest NHS test and trace information</u> has been shared with staff and parents noting: Self-isolation of close contacts will only be undertaken on advice from NHS Test and Trace or Public Health where they are over 18 years 6 months and are not fully vaccinated. Self-isolation of positive cases may end early with two negative LFD tests on days 6 and 7 (or later) and they do not have a high temperature. Hygiene – general	• A process is in place for removing face coverings from pupils who use them when they arrive at school.
