In particular it will not detect individuals who are recovering from having had the virus.</li> <li>A negative LFT does not allow the individual to pause compliance with the requirements of the national lockdown, and they must continue observing covid rules within school, and social distancing and good hand hygiene outside the workplace.</li> <li>The testing programme does not replace current (PCR) testing policy for those with symptoms.</li> </ul>	~	The training provided to staff set out how to monitor the results and what to do should symptoms arise or if there is a positive result.
